The Commissioner has formed the Prestige Worldwide Fantasy Football Bylaws, herein referred to as "the League," to govern the transactions and communications within the League to establish a fair and competitive league environment.

Article I. Contacting The Commissioner

The Commissioner is available if you have any questions or need assistance interpreting league bylaws. If your question pertains to a feature provided by our fantasy football hosting provider, please utilize their support resources.

For league-specific issues, please **contact The Commissioner**. If you cannot contact The Commissioner and your issue is time-sensitive (for instance, if you are requesting a trade approval to use players that week), please contact the Assistant Commissioner. In this way, we can verify the time of your request and make your roster change retroactively if necessary.

Article II. League Entry & Payout

Entry Fee: \$50 per team

Payouts:

• League Champion: \$400

• Runner-Up: \$50

• Weekly: \$10 bonus to the Top Point Scorer for Weeks 1-15

*Amendments to the "Entry Fee" require 10 of 12 Owner votes

Article III. Playoff Configuration

Top three (3) teams in *each* division will make the playoffs for a total of six (6) playoff teams.

• The "top" teams will be determined first by win/loss record and, if necessary, total points for will be the tie-breaker

Top seed in each division earns 1st round bye

• No. 1 seeds are still eligible to receive \$10 bonus payout for Top Point Scorer

Playoffs will begin Week 14 and will last three (3) weeks through Week 16

There is also a loser's bracket, for the losers. Zero implications, better luck next year.

Article IV. Draft Order

The final six (6) spots of the draft, picks 7-12, will be reverse order of the Playoff Bracket results from the prior year.

The first six picks (6) of the draft will be determined via Lottery System.

The odds for the lottery will be determined off the end of the *regular season* records (Loser's Playoff Bracket is irrelevant).

• 12th place: 28.6%

• 11th place: 23.8%

• 10th place: 19.0%

• 9th place: 14.3%

• 8th place: 9.5%

• 7th place: 4.8%

Article V. Keeper Rules

With the rule of two keepers established, the draft, in theory, begins in the third round. As such, in referencing the draft rounds, the "first" round of the draft shall hereby be referred to as the "third" round to keep consistent with the first year of the league, in which there were no keepers. The first keeper may be originally drafted in Rounds 3-18. The second keeper may be originally drafted in Rounds 5-18.

The maximum length of each keeper contract is THREE (3) years.

^{*}Amendments to the draft order system require 8 of 12 Owner votes.

Trade Deadlines and Guideline Article VI.

Deadline 1: End of Week 4

This is the last week teams will be allowed to include draft pick compensation in

trades until the off-season

Deadline 2: Thanksgiving Week – For ALL trades

Trade Guideline:

All trades must be completed and submitted for The Commissioner's approval 24 hours

before the week's first game. All trades are subject to The Commissioner's approval,

unless the League overrules The Commissioner's decision. Once the trade has been

accepted by both parties it is BINDING, pending approval. Should one party withdraw

the trade, The Commissioner shall enforce the trade upon its approval.

League Veto/Overrule:

Requires 5 Owner votes (excluding The Commissioner and two parties involved in the

trade).

Creating New League Rules Article VII.

When a league dispute arises, which has not been addressed in the league constitution, a

discussion will ensue on possible resolutions to the dispute. Based on these discussions,

the Commissioner will create a GroupMe poll so that owners can vote on an appropriate

course of action.

The league will follow the course of action based on the majority vote on the poll. The

poll will be valid so long as there are seven (7) or more votes. Subsequently, the new

rule will be added to the Constitution, herein.

Article VIII. Amendments

1. The Lamar Jackson Clause

Upon the exit/dismissal of a league owner, a new league owner shall be accepted by The Commissioner. The prospective league owner will inherent the previous owner's team *in its entirety*. The new league owner will have no prior knowledge of the make-up of the team and will be subject to the same keeper rules as the rest of the owners.
